## JULIUS ATHENODORUS, PRAESES THEBAIDOS

The purpose of this paper is to publish the full text of Cairo Cat. Gén. 10268, besides P.Beatty Panop. 1 and 2 the only papyrus so far to evidence the tenure of the office of praeses Thebaidos by Athenodorus its first recorded holder (see J.Lallemand, L'administration civile, 249 – 250). A summary description of the Cairo papyrus was given by Grenfell and Hunt in the Catalogue Général but no fuller publication has ever appeared. I am grateful to the Director of the Egyptian Museum for permission to publish Cat. Gén. 10268, and to the editor for his invitation to contribute to this Bulletin and thus for the opportunity to present this papyrus here. This edition has been prepared from a photograph I owe to my colleagues Professor Herwig Maehler and Dr. Adam Buelow-Jacobsen who collaborated in the first part of the 1980/1 Cairo mission for the International Papyrological Photographic Archive in Brussels.

The papyrus preserves the conclusion of a report of legal proceedings before the praceses involving the guardianship of a minor, perhaps concerning some property. The settlement of the affair has been delegated to a iudex datus. Grenfell and Hunt say the provenance may be Hermopolis; the full transcript of the papyrus reveals nothing which will confirm or deny that.

For the bilingual format (Latin framework, Greek speeches), cf. R.A. Coles, Reports of proceedings, 36 – 38. Numerous paperi with proceedings have been published since 1966<sup>1</sup>: bilingual examples to note are CPR VII 21 (With the corrections of J.R. Rea, ZPE 41 (1981); 281 – 2: C.A.D 301) and P.OXY. still the earliest of the 'Byzantine' papyri with bilingual proceedings. It is not clear whether both languages here are written by the same hand. Spacing in 11 could suggest that they are not (and cf. Cat. Gén. 10723 below, Where the Latin may be by the same hand as here but the Greek seems different).

Written along the fibres in column-format not transversa charta as legal proceedings commonly are from the early fourth century on. The second column was the last, as the deeper lower margin indicates. The papyrus has been folded from right to left: there are nine vertical folds at intervals increasing to the left. There is one kollesis, overlapping as usual left over right; its right edge coincides with the third vertical fold from the left The back is blank.

(11.3ff.) "... he ordered(?) a guardian to be appointed for the child, the daughter of Claudianus (the guardians for the boy being(?) Timagenes and Helladius). from that time until today when I brought the case.".

Athenodorus, vir perfectissimus, praeses of the Thebaid, said to him (her?): "Since a guardian was named for the girl minor, then the court can legally be convened which will hear the case within fifteen days." Demetria said: "Unless he first produces proof of how it(?) came to him, let him in no way prevail."

Athenodorus, vir perfectissimus, praeses of the Thebaid, said to her: "The index datus knows how he must abide by the laws."

- 1. The utterances of the praeses start a new line in each case (lines 2, 7, 11; cf. R.A. Coles, Reports of Proceedings 54 n.3); thus the right-hand part of this line could have been blank.
- 2. Athenodorus. See J.Lallemand, L'administration civile, 249 250. I know of no further evidence for him. PLRE I p. 122 adds nothing further (but miscalculates a date: for Jan.29 read Jan.30). His earliest recorded date is 15 September 298 (P.Beatty Panop. 1.127); this might be pushed back to 12–13 September if the day-figure in ibid 79 could be restored as Thoth 15 or 16. His latest date is 30 January 300 (P. Beatty Panop. 2.58, 60). His nomem Julius is supplied by the P. Beatty Panop. references. For his successor Aurelius Reginus see J.R. Rea's note on CPR VII 21 in ZPE 41 (1981), 281 2.
- 2—3 A change of speaker (after Athenodorus) must come in these lines, indicated in Latin. The remaining traces are extremely fragmentary but a possible location is halfway along 3 where there may be remains of a Latin r (cf. Demetria in 9).

I include by way of a supplement the text of Cat.Gén. 10723, which Grenfell and Hunt in the Catalogue Général (pp. 35, 88) suggest may belong to Cat. Gén. 10268. This edition, which has been prepared from a photograph made by the 1973 mission for the Photographic Archive, is presented also with the kind permission of the Egyptian Museum. The provenance may be Hermopolis, according to the Catalogue Général:; there is nothing in the content to confirm or deny this. No kollesis is Visible Written along the fibres; the papyrus has ben gummed on to card and I have not therefore seen the back. I suspect that like Cat.Gén. 10268 the papyrus was written in column-format and not transversa charts.

Obviously the content, bilingual proceedings, is the same as Cat.Gén. 10268, and the Latin hand is similar and the date must be close. But while the proceedings in Cat.Gén.10723 are also before the **praeses Thebaidos**, there are no grounds hands are different and I do not believe the two papyri belong together.
